SUBJECT: VaWC WIOA Title I Data Change Requests

EFFECTIVE DATE: August 17, 2020

PURPOSE:

To provide guidance to Local Workforce Development Areas (LWDAs) and their service providers regarding corrections to data entered into the Virginia Workforce Connection (VaWC). The VaWC is the system of record for Workforce Innovation and Opportunity Act (WIOA) Title I activity and Participant reporting in the Commonwealth of Virginia. As such, it is imperative that data collected in VaWC be complete and accurate. This Virginia Workforce Letter provides a structured process for ensuring changes and corrections to participant data accurately reflect actions taken during their program and post-program participation.

VaWC Data Change Request:

WIOA Title I staff will communicate the need for any data correction to their specific LWDA VaWC System Administrator. Any corrections that cannot be completed by the LWDA VaWC System Administrator should be communicated to the State WIOA System Administrator for review. The State WIOA VaWC System Administrator shall review the validity of the correction and communicate the appropriate action and/or outcome with the LWDA VaWC System Administrator.

Most information can be submitted via e-mail; however, it is extremely critical that Personally Identifiable Information (PII), such as Social Security Numbers (SSNs), not be included in any e-mailed communications. When identifying clients in e-mail communications, staff should identify the clients by their system generated State Identification number. Any requests for data changes must be reviewed and approved by the LWDA VaWC System Administrator. Supporting documentation regarding any data change request should be maintained by the LWDA VaWC System Administrator. The VaWC WIOA Data Change Request form (See Attachment A) must be used to report required data changes to the State WIOA VaWC System Administrator and these changes must be submitted in a timely manner. These forms are subject to monitoring and inclusion in data validation support documentation.

Correction requests submitted on a locally developed form or simply in the body of an e-mail will not be considered or processed and will be returned to the sender.
